TERMS AND CONDITIONS

Golf Membership entitles the Member(s) to unlimited green fees for the 2024 season. A limit of 400 Memberships will be sold for the season. Memberships are non-refundable and non-transferrable. (*Special provisions may be considered for Illness or Injury*). “Resident” Membership(s) are available for those who reside in Bangor, Maine at time of application. All other parties are considered “Non-Residents”. **New membership applications and payments must be completed in person. All transactions must be accompanied by this completed form signed by the member.**

PAYMENT SCHEDULE

A deposit of \$200.00 is required to reserve a membership for the 2024 golf season. All membership fees must be paid in full by May 15, 2024. Upon closure of the clubhouse, payments may be made by mailing a check to the golf course, 278 Webster Avenue, or by visiting the Bangor Parks and Recreation office at 647 Main Street. Failure to comply with the payment deadline will result in forfeiture of membership. Fees paid toward an unpaid membership will be placed on a gift card with no expiration. Associated fees may be withheld from this balance based on rounds already played. **No monetary refunds will be given.** Memberships that are not paid in full will immediately become available to interested parties on the official wait list.

ILLNESS OR DEPLOYMENT

Refunds may be available for illness/injury or military deployment upon request. Such requests will only be considered prior to July 1st and should be submitted via email or in writing to the Head Golf Professional for review with the Director of Parks and Recreation.

JUNIOR, YOUNG ADULT, AND SENIOR MEMBERSHIPS

Junior Memberships are available to individuals under the age of 18 at time of application. Young Adult Memberships are available to individuals between the ages of 18 and 25 at time of application. Senior Memberships are available to those ages 62 and older at time of application.

MULTI PERSON MEMBERSHIPS

Family Memberships are limited to immediate family members residing at the same address. This may include Spouses/Significant Others (*2 individuals*) and children under the age of 18 years old. Couple Memberships included Spouses/Significant others who reside at the same address. Senior Couple Members must both be age 62 or older.

RESTRICTIONS

Senior Members may not play on weekends prior to 12:00 PM. Junior Members may not play on weekends prior to 12:00 PM unless playing with and immediate family member. This includes Juniors playing under a Family Membership.
